**PSA & BGS Grading Terms & Conditions**

By submitting trading cards to Puck & Son TCG for grading with Professional Sports Authenticator (PSA) and/or Beckett Grading Services (BGS), you confirm that you have read, understood, and agreed to the following Terms & Conditions.

---

**1. Service Overview & Authorisation**

Puck & Son TCG ("the Business") acts solely as a submission facilitator for third-party grading services, including PSA and BGS.

By submitting your cards, you:

- Authorise Puck & Son TCG to act on your behalf in all dealings with PSA and/or BGS
- Acknowledge that all grading, authentication, encapsulation, subgrades (where applicable), and processing decisions are made exclusively by PSA or BGS
- Accept that Puck & Son TCG has no influence over grading outcomes, assigned grades, labels, or determinations
- Puck & Son TCG reserves the right, in its sole discretion, to defer any submission requiring additional services to a subsequent submission cycle if received within three (3) business days of the applicable cut-off date. No liability is accepted for delays arising from the inclusion of additional services.

**2. Submission Requirements & Cut-Off Dates**

- Cards must be received at the Puck & Son TCG office to be included in a grading submission
- PSA submissions must be received by **the 25th of each month** to be included in the PSA submission sent on the **first Monday of the following month**.
- BGS submissions must be received by **the 5th of each month** to be included in the BGS submission sent on the **third Monday of the same month**.
- Submissions received after the cut-off will be held for the following month

All cards must be packaged appropriately to minimise the risk of damage during handling and transit.

---

**3. Card Preparation Standards**

- All cards must be submitted in a Card Saver, unless otherwise specified by PSA or BGS
- Cards not submitted in a Card Saver will incur a \$1.00 fee per card for transfer prior to submission

- Submissions that do not meet minimum preparation standards may be delayed or refused

---

#### **4. Submission Confirmation & Tracking**

Once your cards are received, you will receive a confirmation email containing:

- A detailed list of your submitted cards
- Instructions on how to track your grading submission

Customers are strongly advised to take clear photos of all cards prior to submission to avoid disputes regarding which cards were submitted or their pre-submission condition.

---

#### **5. Turnaround Times**

- All turnaround times are estimates only and are provided by PSA and/or BGS
- Actual processing times may vary due to grading company workload, internal processes, or operational delays
- PSA and BGS may take longer than expected to complete submissions

#### **6. Fees, Payment & Upcharges**

- Full payment is required at the time of submission
- Pricing is based on PSA's and/or BGS's published rates at the time the submission is lodged

##### **Upcharges**

If PSA or BGS determines that a card's post-grading fair market value exceeds the maximum value permitted for the selected service level, the grading company may reassign the card to a higher tier.

- The resulting price difference is referred to as an upcharge
- Any upcharges will be invoiced to the customer
- Upcharges must be paid in full before the submission is released
- Failure to pay upcharges may result in delays or the grading company holding the cards until payment is received

---

#### **7. Insurance, Risk & Liability**

By submitting cards, you acknowledge that:

- Puck & Son TCG assumes responsibility for the cards once received and until they are returned to you
- Cards will be insured on your behalf for the declared value provided in the submission form

If cards are lost or irreparably damaged while under the responsibility of Puck & Son TCG:

- Liability for loss or damage is capped at the lower of:
  - The value declared by the customer, or
  - The market value at the time any payout is made
- Any valuation determination will be made by the Business acting reasonably

---

### **8. Limitations of Responsibility**

Puck & Son TCG is not responsible for:

- PSA or BGS grading outcomes, subgrades, labels, or differences between expected and assigned grades
- Changes in market value before or after grading
- Population reports, authentication determinations, or label errors issued by PSA or BGS
- Operational delays, policy changes, or procedural decisions made by PSA or BGS

---

### **9. Cancellations, Changes & Returns**

- Submissions cannot be cancelled or modified once sent to PSA or BGS
- Once graded cards are returned and all fees (including upcharges) are paid in full, customers will be notified for collection or shipment
- Return shipping costs are the responsibility of the customer unless otherwise stated

---

### **10. Acceptance of Terms & Fiscal Responsibility**

Failure to agree to these Terms & Conditions results in Puck & Son TCG having no fiscal responsibility for loss or damage of items submitted for PSA or BGS grading.

By submitting your cards, you confirm that you:

- Have read and understood these Terms & Conditions
- Accept PSA's and/or BGS's grading standards, subgrades, and decisions
- Agree to all fees, turnaround estimates, insurance limits, and potential upcharges
